# **Border Fence**

"Now there was a famine in the land. So Abram went down to Egypt to reside there as an alien, for the famine was severe in the land."

Gen 12:10 (NRSV)

#### Information:

The northern and southern borders are the home to millions of people and the port of entry for nearly \$830 billion of goods. Additionally over half of the visitors to the US arrive through the use of land ports of entry. While there is a need to protect the interests of the United States, the measures that have been enacted over the last decade have come at great social and economic costs.

The construction of border fence, designed to keep out pedestrians and vehicles, was predicted to cost \$1.3 million per mile but has averaged a cost of \$3.9 million per mile<sup>1</sup>. Congress has approved 700 miles of fence but with over 1,952 miles of border there are questions as to the effectiveness of this strategy. The Department of Homeland Security is experimenting with computerized surveillance, known as SBI, originally budgeted for \$20 million but costs could reach \$8 billion through 2013<sup>2</sup>.

## Insight:

In reality, the funds spent in the effort to secure the border have not been the solution to the US immigration woes. The flow of migrants has adapted to the enforcement measures by entering via more dangerous routes into the US and as a result deaths have tripled at the border.<sup>3</sup> Since 1998, 3,348 immigrants have died along the US/Mexico border.<sup>4</sup> The increased dangers associated with crossing the border have meant fewer people are risking traveling back and forth across the border to visit their families and many are bringing in their entire families, putting children and women at risk, for the sake of family unity.

Apprehensions at the border had remained fairly consistent with 1.2 million apprehensions in 1992 and again in 2004 despite the heavy burden of lives lost and financial pressures. However, in 2008 and 2009 apprehensions have been significantly lower and could be due in part of a faltering US economy. Many more migrants have reported paying a smuggler in order to increase their chances of crossing the border. These costs have also risen to approximately \$3,000 and put migrants at the mercy of smugglers.

The monetary and human costs of securing the border in the manner we are currently employing in order to prevent undocumented migration into the US far outweigh the benefits of these programs. Until there are accessible options for families to immigrate to the United States either as residents or temporary workers, men and women will continue to risk their lives crossing the border for the sake of their families' future. Only comprehensive immigration reform that takes into account the labor needs of the US as well as the needs of migrants, will curtail these problems.
