Please read carefully—these are legal documents which affect your rights

The document must be completed by the parent/legal guardian of a minor (who will be under the age of 18 on June 17, 2022) who is elected to be a Young Adult Advisory Delegate to the General Assembly. It must be notarized, and submitted to the stated clerk of the presbytery to be forwarded to the Office of the General Assembly at the time the presbytery reports the name of the elected delegate.

I hereby give permission for this Minor to participate as a Young Adult Advisory Delegate (YAAD) for _____ (presbytery) at the 225th General Assembly (2022) of the Presbyterian Church (U.S.A.) (“GA”) which will be held June 18 – July 9, 2022. Some of its meetings will take place in Louisville, Kentucky, and others as online gatherings using Zoom or similar platforms. I, or another parent/legal guardian of this Minor will accompany him/her when traveling to and from Louisville and be present (seated with other observers) during all meetings and gatherings held there. I will be available to provide in-person consent for any necessary medical or dental treatment during this time. I understand that I may observe the virtual meetings (without visual or verbal participation) by contacting the G.A. Meeting Service in advance.

I hereby acknowledge that the Presbyterian Church (U.S.A.), A Corporation and its related and affiliated agencies, institutions, related entities, members, successors, officers, employees, ecumenical partners, assigns, representatives, and agents (“Agents”) do not assume any liability for harm, loss or damage to this Minor's personal property or for injury, sickness or death arising out of the Minor's participation as a YAAD at the GA. I, my successors, and assigns, hereby waive any claims, demands or causes of action, against the Presbyterian Church (U.S.A.), A Corporation and its Agents for any loss or damage to the Minor's personal property or any injury, sickness or death, which may arise out of participation as a YAAD at the GA, or which may arise during travel to, from, and at the GA.

Further, I understand that the activities in which the Minor will participate include, but are not limited to, the following: plenary meetings of the GA and worship services (most conducted online); committee meetings (held in-person in Louisville); orientation and caucus meetings of YAADs (online and in-person); and special events. I understand that the Presbyterian Church (U.S.A.), A Corporation and its Agents, do not provide chaperones for the YAADs or other participants during these activities and that participation in the in-person portion of the GA will also include free time which is not supervised.

I understand that the online sessions will be recorded, and that photographers, reporters, videographers, historians, and many others will be capturing moments at this GA and that any participant may find his/her image, voice, or quotes used in reporting or promotion. I give Presbyterian Church (U.S.A.), A Corporation and its Agents, permission to use my Minor’s photographs, image, voice/audio, feedback, and quotes on a

perpetual, worldwide, irrevocable basis in any and all media including, but not limited to, websites, print, cable and broadcast media without submission or re-submission for approval. I understand that the photographs, images, voice/audio, and quotes, may be used for any and all purposes of the Presbyterian Church (U.S.A.), A Corporation, its Agents, including use on their web page, cable and broadcast use without re-submission to me for approval. I understand that third parties accessing web pages can download these photographs, images, voices/audio, and quotes, and I release the Presbyterian Church (U.S.A.), A Corporation and its Agents from any liability to my Minor, or his/her parents/guardians, in connection with or arising out of such downloading by third parties. During the online gatherings, if I do not want this Minor's image to be shared, I am responsible for ensuring that the camera on his/her device is turned off or blocked so the image will not be projected in the meetings of and the events associated with this event.
